- Legal classification as follows: §76 Fliegende Bauten LBauO RLP
- Extract from the legal text:
- Temporary structures are structures that are suitable and intended to be repeatedly erected and dismantled at different locations.
- In this case, this applies to all tents over 75 m². According to the resolution from the 88th meeting of the Working Group for Temporary Structures, tent-type awnings on vehicles must be considered part of a unit with the vehicle and the respective areas. This is to be done to form a structural installation. If the total area of both components exceeds 75 m², the "LBauO RLP" must be applied.
- The other provisions of the "LBauO RLP" must also be observed.

Procedure

- A valid work permit and the inspection log book are required for acceptance of use when erecting a workshop tent over 75 m² (temporary structure).
- All documents must be provided in German.
- The ballast to be provided in accordance with the statistics must be procured by the tent operator himself. The race track only provides ballast weights to a limited extent.
- Ground anchors such as pegs or similar are not permitted.
- The organizer must always be notified in writing of the erection of workshop tents.

Acceptance of the workshop tent

- The organizer or the transferor of use is responsible for ensuring and implementing the above-mentioned "LBauO RLP"; Nürburgring 1927 GmbH & Co. KG is not responsible for this.
- The marquee operator must certify to the responsible office that all proofs of stability for the erected workshop marquees have been submitted and properly checked. This is based on a checklist countersigned by the inspection office.

- The Ahrweiler district administration is authorized to carry out a corresponding inspection.
- Workshop tents that do not comply with the conditions are strictly prohibited.
 Violators will have their tents dismantled and face severe fine.

Emergency planning

- Each tent operator must register with the organizer and nominate a person responsible for tent emergency management. This person must have a mobile phone number and be available as a contact person at all times during the event. This includes the setup and dismantling phases. The nominated person must be present in the event area and immediately initiate and carry out the necessary measures to stop operations.
- In the event of expected, significant weather events with announced gusts of wind of ≥ 21.09 m/s (wind force ≥ 8 Bft.) and in the event of strong thunderstorms in conjunction with gusts of wind, the paddock supervisor, the paddock PA system, and a text message distribution list will inform those responsible for the tents accordingly.
- The tent operators of the workshop tents must take all measures to cease operations immediately (removal of the tarpaulins, evacuation of any guests and staff).
- The tent operator must ensure that mobile equipment such as small exhibits, furniture, and sunshades can be dismantled and stored at short notice in the event of a severe weather warning. Storage facilities must be provided at the tent.
