 - 5 the appointed persons, the voluntary assistants and delegates of the persons or organisations specified sub 1, 2, 3 and 4;
 - 6 the insurers of the persons (or organisations) specified sub 1, 2, 3, 4 and 5;
- for all damage I might suffer during the international track day. The present waiver also includes the commitment that, in case of decease, my rightful claimants, my heirs, my in-laws or our insurers cannot exercise their rights.

We would like to remind you that the team/driver is responsible for any damage to the infrastructure (e.g. box, track) of Circuit Zolder which is caused during the execution of his activity. The damage will be invoiced.

ABSOLUTE MOTOR SILENCE

There is complete motor silence for vehicles with combustion engines:

- until 09:00 AM
- between 12:00 PM and 01:00 PM
- after 05:00 PM

Before and after the times from beginning and ending there must be complete motor silence for all vehicles with combustion engines.

Furthermore, it is strictly forbidden for any kind of vehicles with combustion engines (car, motorcycle, scooter, ...) to drive on the track, in the pitlane or in the paddock during the motor silence. Starting the engine in the paddock and in the garages is also forbidden during the motor silence.

The motor silence is obliged for every car, each infraction can be fined with a penalty going on from € 500,00 to even exclusion from the testing day.

The roads on the domain are subject to a speed limitation of 30 km/h. Dangerous driving is strictly forbidden.
